without aid now or in future in respect of Bhashyam Blooms High School, Ring Road, Guntur without aid now or in future.

The Deputy Educational Officer, Guntur, Guntur District is instructed to obtain the required documents by the end of the April every year, the Educational Agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply the instructions issued in reference (5) read above. Any deviation in the above matter action will be viewed seriously and initiate action for withdrawal of Recognition of the school without any further notice.

Further, the managing committee of the school is requested to fulfill all the requirements to cope up with the needs of the institution at the latest before submitting the application for Renewal of Recognition for the year 2029-2030.
